## **Formal Consultation Process and Methodology**

The school's formal consultation exercise ran from **26<sup>th</sup> September – 24<sup>th</sup> October 2023**.

On 26<sup>th</sup> September 2023, the school distributed a formal consultation letter (including a link to a formal consultation questionnaire and a link to attend presentation events to hear more and ask questions) plus an information pack to all parents/carers and staff. Wider stakeholders also received a consultation letter including Multi-Academy Trusts, Trade Unions, the Diocese of Bristol, Diocese of Salisbury, South Gloucestershire Council and Wiltshire Council.

On Tuesday 10<sup>th</sup> October and Wednesday 18<sup>th</sup> October a virtual presentation event was held. Attendees included a mix of parent/carers and governors from across all consulting schools. Approximately 50 people attended over the course of the two sessions. In addition, during the summer term 2023, 4 governor information sessions were also held face to face on the 2<sup>nd</sup>, 3<sup>rd</sup>, 9<sup>th</sup> and 10<sup>th</sup> May.

On Wednesday 11<sup>th</sup> October a face-to-face opportunity and then a virtual presentation event was held for staff on the same day. Approximately 25 members of staff attended. Two staff information sessions were also hosted on 6<sup>th</sup> and 12<sup>th</sup> June face to face and virtually with over 150 attendees across the two sessions.

Responses to the questions raised by all participating schools' respondents have been provided by a collated Frequently Asked Questions (FAQ) document which will be emailed to all parents / carers after 4<sup>th</sup> November 2023.

## **Gathering and Analysing the Consultation Returns**

## **Consultation with Recognised Trade Union Representatives**

On 2<sup>nd</sup> October notification was sent to local and national Trade Union representatives together with the consultation information pack, informing them of a virtual meeting to be held on Thursday 12<sup>th</sup> October at 1pm to clarify the rationale for the proposal, the expected benefits and target opening date and respond to comments and questions raised.

On 12<sup>th</sup> October 2023 at 1.00pm, Andrew Best, Trust CEO Designate and Geraldine Tidy, proposed Trust Director of Education met the Trade Union (TU) representatives who had accepted the invitation: Amanda Martin, NAHT Multi Academy Trust Strategy Officer.

TU questions included: conversion timeline, staff feedback, professional and career development opportunities, Terms and Conditions and support for TU time.

Relevant NAHT members had met with Amanda Martin and local NAHT TU representatives prior to the 12<sup>th</sup> October. No concerns had been raised.

Information shared online during the meeting was sent to all local and national TU representatives on 13<sup>th</sup> October 2023.

## **Conclusions**

One of every governing body's core functions is to ensure clarity of vision, ethos and strategic direction.

The school's governing body has carefully considered the current educational landscape, the formal consultation responses, and due diligence outcomes they completed in collaboration with other primary schools to shape the proposal. Together, governors and leaders have helped to determine the MAT vision and values, benefits for children, staffing and financial models and governance structure.

All reasonable efforts have been made by the school to communicate updates about the proposal informally, and a four-week opportunity was given for all key stakeholders (including staff, parents, and pupils) to participate in the formal consultation process between 26<sup>th</sup> September – 24<sup>th</sup> October 2023. In addition, a formal consultation meeting was held separately with recognised trade union representatives.

Analysis of all formal consultation returns received shows most respondents agree with the proposal. The target opening date is April – June 2024.
